

Terms and conditions of sale - SEE MEET Slovenia 2020 (hereafter “Conference”)

Article 1:

The participant will register through B2Match Platform and will receive a pro forma invoice from the organizer. The participant shall send payment via bank transfer to Razvojni center Novo Mesto d.o.o. (RC NM) for the selected registration package. In case that the payment term is not honored, RC NM reserves the right to cancel the registration and to hold the company responsible for this cancellation.

Article 2:

Registration fees paid by the company for this Conference shall include the following services:

- Entry to Business Conference;
- Access to the SEE MEET 2020 online catalogue of registered companies for one year;
- Up to 15 pre-arranged meetings over 2 days;
- Thematic lectures;
- Access to experts and international stands in exhibition hall;
- A full meal and refreshments during two days;
- Social evening with dinner;
- Matchmaking smartphone APP (real time schedule).

Payment terms: 15 days from date of pro forma invoice, if registered after the 15th of September 2020, payment will have to be made latest until 30th of September 2020.

Price is without VAT (VAT in Slovenia is 22 %)

Any services which are not included in the various package options, i.e. meals and additional breakfasts and any other expenses not listed in this document, shall be charged to the participant and paid directly by him to the service provider, it`s being understood that RC NM shall not be held jointly liable for any debts incurred by the participant.

RC NM shall not, in any event whatsoever, be held liable for the non-attribution or non-payment of any public subsidies granted to a company that is registered with the Conference.

Article 3:

a) Obligations in relation to the Conference:

The company undertakes to fill in a description of its business and detailing the type of alliances and business opportunities sought, through B2Match Platform. RC NM reserves the right to cancel a company's participation and to hold it responsible for this cancellation if the company does not provide the items and documents required for the purpose of the service which it has undertaken to provide, within the proper time limits. During the Conference, the participant will have the opportunity to meet most of the companies that they selected. He commits to attend all meetings, even if it wasn't one of his choices. RC NM cannot be held responsible for any incomplete and/or incorrect information published in the Conference's catalogue. RC NM reserves the right to refuse a company's participation if its size and the object of its business activities do not correspond to the aim of the Conference. In this event, RC NM is not liable for any expenses incurred by the participant.

b) Use of internet during the Conference:

When availing of the Internet access provided during the Conference, the user will refrain from transmitting or downloading any prohibited, illicit, immoral or illegal data, contrary to law or public order that may affect the rights of a third party, in particular with regard to intellectual, literary, artistic or photographic property rights. The user will refrain from any fraudulent or excessive use which could disrupt the availability of the Internet service. RC NM will not be held responsible for damages which may result from the use of this Internet access nor for disturbances or interruptions in the service.

c) Civil liability of the participants:

Each participant agrees to check the extent of its civil liability with its insurance company for the entire duration of the Conference.

d) Communication:

During the event, photos and videos will be taken by the personnel of the Conference. On this occasion, participants expressly agree that their image is used for reproduction on closing day, for communication (paper or digital media and social networks) in Slovenia and abroad, or marketing purposes of SEE MEET during future advertising campaigns. f) Follow-up of the Conference:

The participant agrees to inform RC NM of any contracts which may be entered into after this event, by filling in the assessment questionnaire presented to it at the end of the Conference.

Article 4: Responsibility

The organizer is not responsible for:

- The attendance or non-attendance to the Conference of a participant and/or the proceedings of the meetings. Meetings are chosen by each participant, who accepts to participate of his/her own free will. The organizer does not guarantee a result or a business opportunity after the Conference.
- The cancellation or interruption of a meeting by a participant. In the event that this occurs, no compensation can be claimed from the organizer after the Conference.
- The information and discussions between the participants during the Conference and especially during the individual meetings. The participants have to keep the content of their conversation confidential. The organizer is not responsible for the nonrespect by one of the participants of the confidentiality obligation.
- Disputes between participants. The organizer is under no obligation to intervene and is not responsible for the consequences of any disputes.

Article 5: Force Majeure

If the Conference can't be held because of an event of « Force Majeure » or a decision of the competent authorities, then an online event will take place instead. In that case, the registration fee for all participants will be 89 EUR/participant (price is without VAT). The participant that already paid the full amount registration fee, will receive a refund of the difference between the paid registration fee and the amount of 89 EUR (price is without VAT).

Article 6: Cancellation terms and conditions:

In case of cancellation before 30th September 2020, the participant will receive a refund in the amount of 50% of the paid registration fee.

In case of cancellation after 30th of September 2020, no refund will be paid, the organizer will retain the total amount. Article 7: Consent to use personal data and documentation (Terms and conditions concerning General data protection regulation – GDPR)

It's unconditionally understood, that by accepting this Terms and conditions, the participant is allowing the Development Centre Novo mesto Ltd, as the host of the Conference to use participants personal and contact data (name, surname, e-mail, mobile/phone number) for the purpose of:

- Proceeding for the participation at The Conference, including collecting of personal documents and photos,
- Informing about activities related to The Conference (schedule, The Conference newsletter, etc.)

- Promoting The Conference via different media channels, including social media

It's also unconditionally understood, that by accepting this Terms and conditions, the participant is allowing the Development Centre Novo mesto Ltd, as the host of the Conference:

- he can lodge an appeal to the competent supervisory authority if I believe that the personal data controller violates the rules on the protection of personal data;
- he can find information on the personal data controller, the authorised person for the protection of personal data and other information related to the use and protection of personal data at the web address www.rc-nm.si;
- the provided personal data will not be processed for any other purpose, as stated above;
- the provided personal data will not be transmitted to third parties, other than those defined by law, contract or other legal basis;
- personal data can also be processed by the contractual partners with whom UP has concluded contracts for processing of personal data and which at the same time provide an adequate level of protection of personal data.

Article 8: Law

These terms and conditions are governed by Slovenian law.

Article 9: Applicable law - Disputes

In case of dispute, Slovenian law only shall have probative force and only RC NM area Courts of Law shall have jurisdiction.
