



Terms and conditions of sale - SEE MEET Slovenia 2017 (hereafter “The Forum”)

Article 1:

In order to register, the organizer will issue an invoice to the participant and the participant shall send payment via bank transfer to Mariborska razvojna agencija p.o. for the selected registration package. In the event that the payment term is not honored, Mariborska razvojna agencija p.o. reserves the right to cancel the registration and to hold the company responsible for this cancellation.

Article 2:

Registration fees paid by the company for this Forum shall include the following services:

- Registration to SEE MEET 2017;
- Access to the SEE MEET 2017 online catalogue of registered companies for one year;
- Up to 15 Personalized one-on-one business meetings;
- Access to expert and international stands in exhibition hall;
- Access to conference, 24th October;
- Warm meal, 24th October and 25th October;
- Refreshments during coffee breaks;
- Networking Dinner, 24th October 2017

Price: 125,00 EUR/participant

Payment terms: 15 days from date of invoice, if registered after the 11th of September 2017, payment will have to be made latest until 25th of September.

Price is without VAT (VAT in Slovenia is 22 %)

Any services which are not included in the various package options, i.e. meals and additional breakfasts and any other expenses not listed in this annexed document, shall be charged to the participant and paid directly by him to the service provider, it being understood that Mariborska razvojna agencija p.o. shall not be held jointly liable for any debts incurred by the participant.

Mariborska razvojna agencija p.o. shall not, in any event whatsoever, be held liable for the non-attribution or non-payment of any public subsidies granted to a company that is registered with the Forum.



Article 3:

a) Obligations in relation to the Forum:

The company undertakes to fill in directly online on the website www.seemeet.si a description of its business and detailing the type of alliances and business opportunities sought. Mariborska razvojna agencija p.o. reserves the right to cancel a company's participation and to hold it responsible for this cancellation if the company does not provide the items and documents required for the purpose of the service which it has undertaken to provide, within the proper time limits. During the forum, the participant will have the opportunity to meet most of the companies that they selected. He commits to attend all meetings, even if it wasn't one of his choices. Mariborska razvojna agencija p.o. cannot be held responsible for any incomplete and/or incorrect information published in the Forum's catalogue. Mariborska razvojna agencija p.o. reserves the right to refuse a company's participation if its size and the object of its business activities do not correspond to the aim of the Forum. In this event, Mariborska razvojna agencija p.o. is not liable for any expenses incurred by the participant.

The organizer does not guarantee a result or a business opportunity after the forum. - The cancellation or interruption of a meeting by a participant. In the event that this occurs, no compensation can be claimed from the organizer after the forum. - The information and discussions between the participants during the forum and especially during the individual meetings. The participants have to keep the content of their conversation confidential. The organizer is not responsible for the nonrespect by one of the participants of the confidentiality obligation. - Disputes between participants. The organizer is under no obligation to intervene and is not responsible for the consequences of any disputes.

Article 5: Force Majeure

If the forum can't be held because of an event of « Force Majeure » or a decision of the competent authorities, no compensation will be paid by the organizer to the companies.
